## **HEALTH + WELL-BEING PROJECT**

**Health + Well-Being** aims to support and enhance healthy practices and social/emotional and behavioral support for community organizations and families.

#### UPDATES | EMBEDDED EARLY CHILDHOOD MENTAL HEALTH CONSULTATION (E-ECMHC):

- Both of JI's ECMH Practitioners resigned at the end of January to pursue private practice and contract work.

  Recruitment has been expanded for these positions, and The Resource Exchange is taking referrals until new consultants are hired. (State ECMH representative notes several ECMH resignations throughout the state.)
- The ECMH fiscal Year 2024 State Contract has been accepted and funding received for ECMH Internship Pilot and partnership with UCCS is pending.

#### **PYRAMID COLORADO**

Twelve Directors attended A Pyramid Directors Roundtable, which offered information on Pyramid scholarships, programming, and opportunities available through Healthy Child Care Colorado. Participant was overwhelmingly positive, with requests for additional programming.

### FAMILY, FRIEND + NEIGHBOR (FFN) PROGRAMING: THE COLORADO HEALTH FOUNDATION

- **JI Playgroups:** These play-based groups introduce music, movement, literacy and school readiness activities to young children and their caregivers and, due to the **overwhelming success**, **have been extended** through May 3rd. This project is a partnership between Joint Initiatives and the Community Cultural Collective and was recently featured on KOAA see coverage **HERE**.
- Outreach paused this month to focus on 49 FFNs currently participating in programming.
- FFN systems building continues with Jefferson County, Fountain Valley CTC, and Fountain and Ellicott school districts to look at expanding services to FFNs.

## QUALITY INITIATIVES PROJECT INTEGRATED WITH PD

**Quality Initiatives (QI)** focus on coaching, outreach, supports, resources/assets, and professional development to enhance quality in early care and education (ECE) programs. #### **QI UPDATES**

#### • CCR+R and Program Outreach

- JI's Foundations Outreach Specialist emailed and called providers within El Paso County to discuss the importance of updating their profile on the PikesPeakEarlyChildhood.org provider portal. The email includes the process of scheduling one-on-one sessions to help providers update their Pikes Peak Early Childhood profile.
- The Foundations Outreach Specialist has engaged in outreach at the JI Playgroup, Simple Gift Scholars Enrichment Training meeting, IREE Child Care Licensing Open Forum, Universal Pre-K Town Hall, Communities That Care Child Care Strategy Team/Fountain Valley CARES meetings, Fountain Valley Communities That Care Community Board Meeting, and BridgeCare Next Steps meeting.
- Colorado Shines Quality Improvement (CSQI) Grant
  JI's new Foundations Early Childhood Manager contacted CSQI MOU
  holders to introduce herself and offered the grant opportunity to
  programs in the rating window and those in submission status.
- Emerging + Expanding Child Care Grant Applications
  A total of 17 El Paso County programs have applied with only one currently holding a CSQI MOU, so there's an opportunity for quality improvement outreach and growth among these applicants.

#### PROFESSIONAL DEVELOPMENT UPDATES

- Workforce Development: Expanding Quality for Infants and Toddlers (EQIT); Early Childhood Trauma;
   Make More, Spend Less, A Recipe for Success; Simple Gift Scholars Early Childhood Teacher Enrichment
   Training; Workplace Culture; and CPR-AED/1st Aid/Medication Administration Part 2
- ECE Career Navigator supports
  - Career pathways; Early Childhood Teacher qualification; Director qualification; Professional
    Development Information System (PDIS) ECE Credential and general technical support; Child
    Development Associate (CDA) assistance; scholarships; and UCCS Inclusive Early Childhood Education
    Apprenticeship Program career goals. In addition, JI's Career Navigator supported two people new to
    the ECE field and two high school students that reached out to the Career Navigator.
  - Assisted four people new to the ECE field two were high school students that reached out to the Career Navigator, and two are interested in opening a Family Child Care Home.
- People keep inquiring about CDA scholarships. We partner with Pikes Peak State College (PPSC) to support them with the new Concurrent Enrollment Hybrid Model for all El Paso County school districts starting this fall. JI created the PPSC Hybrid Model flyer for the PPSC Assistant Director of Concurrent Enrollment to send to all the school districts.
- JI's Foundations Partner Recruiter offered **three presentations about the importance of Early Childhood Education (ECE) and career opportunities** at three different high school events. High school teachers received JI's ECE Career Opportunities + Pathways document.
- **ECE Boost Workforce Retention survey results** indicate common patterns, including staff shortages, low pay, challenging behaviors, staff overwhelmed by too many jobs under one role, burnout, stress, too much paperwork to fill out, and leadership team management.
- In addition to our trauma training offered through the Foundations PD Catalog, the Foundations Trauma Coach + Trainer has **supported 192 teachers and administrators** with on-site trauma training at several early childhood programs. This includes **one-on-one trauma coaching for seven** training participants.

In January, information on **Universal Pre-K** was shared, and the committee was updated on the **JI Playgroups** and **Pikes Peak Library District events** for families.

In February, 15 stakeholders attended and shared this is a valuable **venue to better understand and share local resources available to families**. The group discussed the best ways to share resources with families this summer.

The **Pyramid Community Leadership Team**, a subcommittee of the Health + Well-Being Committee, met in January to discuss upcoming scholarships through Healthy Child Care Colorado. Sixteen Pyramid stakeholders have signed up for an in-person **Pyramid Strategic Planning Session** in early March.

#### El Paso County

- Approximately **2,500 family applications** have been submitted...
- 145 UPK provider applications
- Over **5,000 slots** have been requested by providers.
- Office Hours for providers will be held on a weekly basis through March 2023.

Colorado | The Deferred Acceptance Algorithm (DAA) ran on 2/27 – Colorado has a total of 27,325 applications for 4-year-olds matched.

- First Choice: 86% matched
- One of preferred choices: 93% matched
- A total of **5.7% of children did not receive a match.** The CDEC is asking LCOs to help contact families to make edits to applications.
- A total of **4,328 3-year-olds** were matched to school districts.
