



<u>Over all budget</u>	increase	Increase of 53,428 (which includes the 28K from HB1307 funds, same as last year)

MTR Updates

MTR provides early intervention for youth identified through municipal and truancy court settings with options for deferred sentences.

Program Highlights as of 7/1/23-1/31/24:

58 Open Care Coordination

4th cohort of Another Pathway (Strengthening Families, an evidence-based youth/parent 5-week class.) Began in JANUARY! 7 adults & 11 youth, our biggest class so far. And we have registration already for the May cohort.

This class includes youth who have had their court cases closed but still wanted to attend with their family, despite having no court obligation to fulfill.

Mission Possible Updates

Mission Possible has provided 24/7 detention screening/assessment for the past 20 years as a subcontractor for the 4th JD - CYDC. Their current contract includes: Detention Screening Care Coordination Supervision

Highlights as of 7/1/23 - 1/31/24:
237 # of detained youth *
462 # of screened youth *
185 # of youth Care Coordination *
168 # of youth under Community Supervision
29 # of youth receiving WRAP
17# of youth Overrides by on-call Judge for detention

The first six months of FY23-24 data indicates Mission Possible screened 391 youth which is a 21% increase over the number of screens at this same time last year. 50% of the screens went to detention, which is a decrease from last year by 14%.

GUIDING PRINCIPLES

Consider least restrictive services/placement; family and youth voice and choice throughout all phases; shared decision making and responsibility among parties; trauma-informed and responsive.


