Metrix Enroll for Universal Preschool Payments

- MetrixIQ is excited to kick off the second half of the school year with an improved payment report process for Universal Preschool. On January 8th, we launched Metrix Enroll for Universal Preschool Payments a web-based portal where you will find your monthly payment reports in one place. The new system also allows us to add student names to the report, which we hope will help make the review of your payments much easier. We are also working on an End of the Year report for providers, including payments received from MetrixIQ (UPK, bonus, grants, etc.). This EOY report will be available via Metrix Enroll as well.
- Providers should have received an email from Metrix Enroll (<u>no-reply@metrixenroll.com</u>) and the subject line "Welcome" with your username and temporary password to activate your Metrix Enroll account. You can see a preview of the system, how to login and download your payment reports here.

TAX CREDITS AND TAX REBATES

What are tax credits?

- Tax credits are decreases in tax owed if eligible
- When the taxes are **refundable** we get that money back in a refund payment if we file taxes
- Payment can come in check or direct deposit

What are tax rebates?

- Tax rebates are refunds of taxes paid
- Most Coloradans will receive a TABOR rebate this year
- Must file a state return to receive



WHAT'S NEW FOR THE 2024 TAX SEASON?

CHILD TAX CREDIT

- Expanded federal CTC ended
- \$2,000 per child for eligible dependents (up to \$1,600 refundable)
- Parents can use an ITIN if child has a SSN
- State CTC 10-60% of federal (no SSN required)
- State CTC is refundable
- State CTC is only for children under 6
- People can still claim missed tax credits back to tax year 2020.

EARNED INCOME TAX CREDIT

- Up to \$7,430 with dependants
- Colorado residents who claim federal EITC can also claim COEITC - 50% match this year!
- ITIN filers can only claim state EITC
- Amount for filers without dependent children is up to \$600







EARLY CHILDHOOD EDUCATOR CREDIT

Credit for credentialed childcare professionals:

- Between \$850 and \$1,620
- Refundable
- AGI less than 75k/150k
- Must hold an EC Credential from CDEC
- Licensed or employed by an eligible program
- Must file a state return + a tax form More information <u>here</u>

UPK BY THE NUMBERS

EPC UPK Year Two Provider Set-Up Summary

- A total of 201 providers have registered for Year Two.
 - 96% of providers from year one have registered for Year Two, putting El Paso County above the state target for provider retention.
 - 28 new providers have registered in El Paso County for Year Two.
 - 15 of these new providers are in high-need areas (areas with less than 70% access)
- There are 6,199 registered UPK seats for Year Two. This has increased access in El Paso County to 66%, 4% away from the benchmark of 70% for universal access. This is an increase of 11% over Year One.
- ZIP codes 80916 and 80910 have both seen increases in access, but are still below 50% on average. These ZIP codes have the highest concentrations of four-year-olds in El Paso County, large military populations, and have among the highest youth poverty in the county.

EPC UPK Year Two Seat Breakdown

- UPK seats in El Paso County are distributed as follows for year two:
 - 24% of UPK seats are IEP seats
 - 20% of UPK seats are full-day seats
 - 16% of UPK seats are other hour type seats (D49 programs are all 12 hours, around 2 dozen private providers also have hours different from 10, 15, or 30 hours)
 - 13% of UPK seats are half-day PM seats
 - 10% of UPK seats are extended-day seats
 - 9% of UPK seats are half-day AM seats
 - 7% of UPK seats are part-time AM seats
 - 1% of UPK seats are part-time PM seats

UPK Year One Reminders (2023-2024)

Year One (2023-24) Reminders

UPK Eligibility

- Only children who were 4 years old prior to October 1, 2023* (year before kindergarten) are eligible for UPK during the current year, regardless of whether they turn 4 after October 1.
- Children who are in their two years before kindergarten during the current school year can only receive UPK support from their home school district. Non-school district providers can still serve these children, but it is without UPK support.

New Applicants

- Families can still apply for the 2023-24 school year. JI is reviewing new applications weekly and sending them to the top two providers that the family chooses.
- If there are many choices, a Family Resource Navigator is reaching out to the family to help them find a placement.

Year One (2023-24) Reminders

Drops and Un-enrollments from your program

- Providers must unenroll a child within one week if the child withdraws or stops attending. Notify LCO by email of the reason for the unenrollment so we can make a note in the child's application.
- If the family stops communicating with the provider, the provider must document the attempts made to contact the family and then must unenroll within one week.
- The provider may continue enrollment for a child as long as they attend sometime during the payment month. If the family leaves for a month, the child must be unenrolled. The provider can save the seat for the child by reducing their UPK number by one and then increasing again when the child returns. To reduce or increase seats, contact JI.

Year One (2023-24) Reminders

Payment Schedule and Issues

- Payment issues should be handled by creating a ticket with MetrixIQ at <u>coupkpayments@metrixiq.com</u>
- The payment report is pulled at the end of the day on the 15th of each month. Students eligible for payment the following month must have a completed enrollment form with a start date that is by the 15th of the payment month.
- According to the payment schedule for the 2023-24 year, the last payment for Year One will be on May 9th for children enrolled as of April 15th and starting by May 14th. There will be a true-up in June for any providers who were not paid correctly. Any concerns or issues should be submitted to MetrixIQ.
- Once a provider's UPK calendar has ended (which should be made clear for families), enrollment over the summer months is at the complete discretion of the provider in accordance with their published rate schedule. THERE IS NO UPK SUPPORT OVER THE SUMMER MONTHS.

Year Two (2024-25)

Major differences between Year One and Year Two

- Priority enrollment (also known as pre-registration or Continuity of Care)
- Matching algorithm run only twice (expected to be April and July), followed by return to walk-in status in August
- Children in their two years before kindergarten without an IEP will be sent directly to the school district for placement and will not go through the UPK system.
- Children in their year before kindergarten with an IEP will be managed directly with the AU/school district for placement.
- Children in their two years before kindergarten with an IEP will submit an application through the UPK system, noting that they have an IEP. These apps will be sent to the AU/school district for placement.

ESTIMATED ENROLLMENT TIMELINE FOR 2024-2025 SCHOOL YEAR



Provider Program Set Up: Providers licensed to educate preschool-aged children can elect to be a UPK Provider by completing the Program Set Up Form at <u>provider.upk.colorado.gov</u> by February 16. Programs submitted after the initial deadline will be available for families at a later date.

Pre-Registration: Estimated to be from February 29 through March 28, families can pre-register with their known provider to continue care for a child currently enrolled, with a sibling currently enrolled, or with a family member currently employed with a UPK Provider.

Family Matching: Estimated to be begin on February 29, families will be able to visit <u>upk.colorado.gov</u> to browse 1000+ high-quality licensed providers and apply to be matched with their top choices during matching rounds expected in April and July. After the match is complete families will work directly with their new provider to finish the enrollment process.

Direct Enrollment: Estimated in July, after the matching rounds end, families can work directly with a UPK Provider to enroll, if space is available, through the end of the school year.

IEP Direct Enrollment: Estimated to begin on February 29, Special Education Administrative Units (AUs) and school districts may request placement of students with IEPs. Students with an IEP will be placed according to their IEP throughout the school year.

Families with priority can enroll in one of two ways:

1. Provider sends a program-specific link to the family that will prepopulate the program where they have priority into their application as 1st choice (Link will not be available until the 2024-25 programs are verified and published)

2. Provider sends a letter to the family stating the site and program where the family has priority and asks them to register at upk.colorado.gov and put that program as their first choice and mark that they have priority

Families who state that they have priority will be sent to the provider weekly during the month to confirm that the family does have priority.

FUNDING AND FINANCING

PAYMENT SCHEDULE

- Colorado Universal Preschool funding will be paid monthly per enrolled child, based on the published rates by LCO and the individual child's eligibility.
- You can find Colorado Universal Preschool rates by LCO and funding level for FY 2023-24 <u>here</u>, listed as the monthly payment and school year total amounts.
- Monthly payments will not be prorated based on attendance. Payments will be based on enrollment status.
- You can review your monthly payment reports through our payment partner's account, MetrixIQ. To activate your account and for instructions on logging in, click <u>here</u>.
- "Eligible funding" is defined as how many program hours the state will fund for a child, depending on the child's award.
 - This could be some, or all of the program's hours that families have elected to participate in.
 - A child's funding award will vary based on the hours they are scheduled to attend preschool each week (i.e., their Colorado Universal Preschool program) and if they qualify for additional funding hours beyond the standard rate.

HOW TO CALCULATE PRIVATE PAY TUITION

- Providers set the amount they will charge families for care. To ensure a sustainable business, your private pay rate must be enough to cover your operational costs. You should consider these costs and any profit you wish to make, to then work backward to set the price you must charge per child.
- Provider budget projections will need to take into account how different children will generate varying amounts of revenue. For example, children who use private pay will generate a different amount of income than those children who qualify for subsidy programs, due to differences in what services are covered by the subsidy. This is why budget projections for both expenses and revenue are important for setting private pay rates.

When determining your tuition rates, consider the following:

- **u** Tuition cannot be collected for Colorado Universal Preschool funded hours.
- How many weeks do you collect tuition in a given year?
- What are your different sources of income? (different age groups, Child and Adult Care Food Program, grants, etc.)
- □ What are your expenses? (insurance, staff wages, rent, supplies, etc.)

Year Two (2024-25)

Programs and rates for 2024-25 (pending approval by JBC)

- Part-Time: Between 10 and 14 hours per week, 36 weeks or a total of 360 hours (\$483.01 per month x 10 months); no charge to family permitted
- Half-Day: Between 15 and 29 hours per week, 36 weeks or a total of 540 hours (\$603.57 per month x 10 months). Fifteen (15) hours are free; families may be charged for hours between 16 and 29 per week.
- Full-Day: 30+ hours per week, 36 weeks (\$1067.92 per month x 10 months); 30 hours are free, families may be charged for hours above 30 hours.*

*This rate is ONLY for those children who qualify for 30 hours per week of UPK and are enrolled in a full- or extended-day UPK program. Otherwise, the provider will be paid for 15 hours per week, and the family will be responsible for the remaining hours of care according to the provider's published rates. For the 2024-25 year, providers MUST publish their rates in their profile so that families have that information before choosing a potential UPK provider.
