# QUALITY INITIATIVES PROJECT INTEGRATED WITH PD

**Quality Initiatives (QI)** focus on coaching, outreach, supports, resources/assets, and professional development to enhance quality in early care and education (ECE) programs. Child Care Resource & Referral (CCR&R) work focuses on outreach to update and support licensed ECE programs, increase capacity for licensed ECE programs, and provide resources and referrals for parents/families for ECE programs. Professional Development (PD) is integrated throughout QI and CCR&R.

# QUALITY INITIATIVES PROJECT INTEGRATED WITH PD

#### COLORADO CHILD CARE ASSISTANCE PROGRAM (CCCAP)

- Two new CCCAP providers through contractor engagement
- Increase of 32 CCCAP slots in El Paso County (7 infant, 7 toddler, 9 preschool , and 12 school- age)

### TRAUMA-RESPONSIVE TRAINING & COACHING

- Virtual Family Trauma Training for ECMH sites with four participants (March 5th)
- Virtual Community Family Trauma Training with two participants (March 8th)
- Challenging Behavior Training (Primrose) with 17 participants
- **Trauma 2** training in Kiowa County with 13 participants

#### **Additional Highlights**

- JI's Career Navigator supports individuals in the areas of career pathways; Early Childhood Teacher qualification; Director qualification; Professional Development Information System (PDIS) ECE Credential and general technical support; Child Development Associate (CDA) assistance; scholarships; and UCCS Inclusive Early Childhood Education Apprenticeship Program career goals.
- Three teachers applied for a credential level on Early Childhood credential 3.0. One of them received a Level 2 and is waiting on response for a Level 3. The other 2 teachers we are waiting for a response.
- **Barriers removed UCCS:** The text messaging group has been extremely helpful to the students, and they have supported each other on assignments. The Career Navigator provided different hotels for a student to stay at when she visited for graduation.
- **Barriers removed:** Applying for FASFA, registering for classes at Pikes Peak State College (PPSC) and PPSC enrollment, navigating PPSC portal, uploading documents to PDIS, searching for transcripts, setting up advisor meeting, applying for a credential level 3.0 on the PDIS, going over and correcting hours and letters of employment, and revising documents for PDIS. Spanish speaking new professional had support in Spanish and was guided on where to start for opening her in-home child care.

# ALLIANCE FOR KIDS COMMITTEE UPDATES

## FAMILY SUPPORT + EDUCATION

The Family Support + Education Committee met with 11 stakeholders in attendance. The guest speaker was Monica Boyd, who shared about the wealth of resources and programs through Army Community Services. The committee reviewed the gaps in services to families in our community and looked at how this committee might fill some of those gaps. The committee discussed gaps in kindergarten transition support and how to best support kindergarten readiness. The group discussed strategies to get parents to attend the committee and a recap of the two family focus groups was shared.

The next meeting will take place on April 18th from 1:00-2:30 pm.

- School District-Based: 69 (all 15 El Paso County school districts participating)
- Family Child Care Homes: **30**
- Center-Based: 80
- Programs accepting CCCAP: 66

- 4-year-olds matched: 4,300 (84%) (4,266 enrolled, 34 accepted)
- 4-year-olds unmatched: 810 (16%)
- 4-year-olds on waitlists: 419 (8.2%)
- 3-year-olds enrolled: 1,155

#### **UPK Seats + Applications**

- Registered UPK Seats: 5,219
- UPK Seats available: 919 (includes available IEP seats)
- Family applications: 12,301
- 1,336 have been withdrawn
  - 3,242 are "in progress" but have not been submitted. It appears many families that are "in progress" for the 2023-2024 school year thought that this was the 2024-2025 application.

#### **UPK Team Assistance**

- Family calls/emails for March: 926
- Provider calls/emails for March: 392

Areas of El Paso County with low availability to meet need are School Districts 2, 38, and 20.

#### TAKEAWAYS AND ADDITIONAL INFORMATION:

- The UPK team had a total of 1,318 contacts in the month of March (70% families).
- Hundreds more in-progress applications came in this month for 2023-2024, most of which were intended to be for 2024-2025. Navigators assisted many families with new applications.
- There are a total of 3,312 active applications 2,641 have been submitted and 671 are in progress.
- Continuity of Care families will receive their matches on April 3rd and will have until April 11th to accept or decline their matches.
