CYDC Updates

Bed Management & Workload Challenges:

The average daily population in the 4th Judicial District is 127%, compared to a regional average of 104%.

The district has seen an increase in high-level charges, leading to strain on court dockets.

Proposed Solutions: Additional beds, more funding, staff hires, and facility improvements.

Erika Knuston presented at the CYDC conference, advocating for the 4th and the challenges we have seen with the workload and bed management.

Troy Paben represented the 4th JD.
